International Public Sector Accounting Standards (IPSAS) have been developed to enhance the quality, consistency and transparency of public sector financial reporting worldwide. Issued by the International Public Sector Accounting Standards Board, IPSAS are accruals-based standards used for the preparation of general purpose financial statements by governments and other public sector entities around the world. They are increasingly being adopted across the Middle East with many ministries transitioning to IPSAS.
